CHIEF EXECUTIVE OFFICER'S REPORT BY BEALS (highlighted areas of written report):

• Funding – Nothing new to report for FY22 Medicaid or for FY22 General Fund.

- COVID Since May 24, 2022, we have only had one staff test positive for COVID (and that was this week). Prior to this positive result and Tuscola County moving back to moderate risk level, we had planned to allow staff to resume in person attendance at conferences and trainings and in person staff meetings at this time, we have not moved forward with this change. However, we remain optimistic that we will be able to make this change soon.
- Staffing Current open positions include the following: ACT Supervisor, 3 part time residential
 1 full time residential, 2 Case Manager/Supports Coordinators (MI), 1 Case Manager/Supports
 Coordinator (DD), 1 Full time Outpatient Therapist (currently on hold), 4 Children's Services
 Workers, Quality Systems/Compliance Supervisor, 2 Registered Nurses, Part time Medical
 Records, Full time Secretarial Support, Acute Care Coordinator, Peer Wellness Coach, and
 Youth Peer Support Specialist. We also have a need for a Speech Therapist as either an
 employee or contractual.

Staff Psychiatrists – We continue to work with Dr. Challa regarding interest in returning to TBHS 30 hours per week. Dr. Challa will be back as a 30 hour per week employee in September. We continue to work with Locum Tenens companies for Locum psychiatrists and continue to look to add additional psychiatrists/additional hours.

- System Redesign Senate bill 714, which is a mental health supplemental bill sponsored by Senator Shirkey passed in the Senate on June 15, 2022. The bill would provide \$565.6 million gross funding (\$17.5 million in GF/GP) directed largely at various aspects of the behavioral health system. \$548.7 million would be sourced from funding through American Rescue Plan Act funds. We did a ZOOM call last week to discuss what passage of the bill means. Originally all funding under SB 714 was tied to passage of SB 597 & SB 598, but some of that did change in the approved version of SB 714. It is believed that Senator Shirkey will be pushing for SB 597 & SB 598 to come up for vote prior to summer recess. It is still uncertain as to whether he has the votes needed for this to pass.
- Purchases We are currently in the process of getting bids on some high-cost purchases. Once we have received the bids required and have prioritized the items, we would expect that we would have at least one item that we will be bringing to the board for approval of the purchase and possible funding through local dollars/or credit purchase. We are getting quotes on a new notification system at PIC, a new exterior camera system at PIC, fencing at PIC, generators for a portion of PIC and/or Burnside. We would obviously not look to make all of these purchases and will have further discussion prior to bringing the request/quotes to the board.
